PRESIDENT'S MESSAGE Bob Cable

Well, we've had it all since the last president's message: Wind, rain, snow, and 80-degree days. Just because it has rained so much, don't make the mistake of thinking that the drought, we were experiencing is over... It will take another 4 or so years of this kind of rain to replenish what the area has used. Your water company, (San Antonio Water Co.) is doing quite

well. The newly reconstructed cross walls in Cucamonga Canyon are doing their job of slowing water for recharge, the Frankish tunnel is flowing again after a very long dry spell and we are seeing a rise in some of our wells. As long as I am on the subject of water, I would like to thank longtime resident John Gerardi for his service on the board of directors of the San Antonio Water Co. representing the residents in the "Heights". John was a wealth of knowledge to our community and I wish him well as he leaves the board. With that, it is my pleasure to welcome Martha Goss (after the April board meeting) to the board of directors. Those of you that know Martha will agree that she will be a great representative for our rights to water in the "Heights".

As you all may have heard by now, we were victorious in our lawsuit against LAFCO and the process that they took to illegally tax us for a fire service that we already pay for. This was a real lesson in the determination and perseverance of our small community as I believe we may be the only organization in California to ever overturn a LAFCO ruling. Where do we go from here? That's a good question that we are discussing with our legal team. Until all the time limits for responses from the opposing party run out, we are in a holding pattern.

Remember to mark your calendars for May 4th as the annual community pancake breakfast will be taking place at Life Bible Fellowship Church. This is a great opportunity to meet your neighbors, representatives from your fire, sheriff and county supervisor (schedules permitting).

Last but not least, none of this could happen without your support as members of the San Antonio Heights Association. If you are already a member, thank you for supporting YOUR community. You should be proud of what we have accomplished in protecting our way of life. If you are reading this and you are not a member, please consider joining and attending a meeting every now and then. 



It is with sadness, that we hear of your retirement from the San Bernardino County Sheriff's Department. The San Antonio Heights Citizen Patrol Unit 434 would like to express our thanks for all you have done for us and our community. It was nice to work with somebody full time, who lived in the Heights, got to know our issues, took the time to try and resolve them. You will be sorely missed!

We know we cannot list all your accomplishments over the past few years, but some that we feel need to be mentioned:

- Heading up the Local Search & Rescue Unit, helping account for countless rescues in Ice House Canyon and Mt. Baldy.
- The mapping and obtaining GPS coordinates of all the cabins in Mt. Baldy area for quick location in case of emergencies.
- Decreasing traffic issues in the Heights with the enforcement of speed limits and the running of stop signs with citations and warnings.
- The establishment of no stopping or parking signs on Mountain Avenue heading to Mt. Baldy, north of 5th Street. This has helped reduce the amount of illegal dumping, drinking and drug use that was a major problem in that area.
- Also set up cameras along Mountain Avenue to catch illegal dumpers in the act. In many cases Rich gave the offender the option to clean up the area or be cited. Either way the word got out that Rich was watching.
- Lastly, maybe not as famous as the shoot-out at the OK Corral, but after countless stakeouts Rich did apprehend the famous avocado thieves at the Keagle Ranch.

We hope you keep in touch and remember us (the stubborn, pain in the a__ old timers). We will fondly remember you and all you did for us. We wish you good luck in all your future endeavors.

SAN ANTONIO HEIGHTS ASSOCIATION ANNUAL MEETING MINUTES - NOVEMBER 1, 2018

President Bob Cable thanked everyone for attending and called the meeting to order at 7:00 p.m. Ken Petschow led the flag salute followed by the invocation by Ray Musser.

Bob Cable thanked Giuseppe's Ristorante for the pizza, Oakmont Retirement Community Center for the cookies, Life Bible Fellowship Church for the use of their facilities, and San Antonio Heights Association for the drinks.

Bob Cable introduced the 2018 San Antonio Heights Association Board Members and speakers: Brian Lee, San Antonio Water Company General Manager; Lisa Petschow, San Antonio Heights Resident; Janice Rutherford, County Supervisor, District 2; John McMahon, San Bernardino County Sheriff-Coroner; Kevin Porter, Captain, California Highway Patrol; Mark Hartwig, Fire Chief, San Bernardino County; and Debbie Stone, Mayor, City of Upland. Also recognized were the Fire and Sheriff's Departments for the service they provide to our community.

San Antonio Water Company (SAWCo) General Manager Brian Lee has been in his new position for two months. He is extremely excited to be here and pleased with the good relationship between SAWCo and the Heights. Brian transferred to SAWCo from Santa Cruz County where they received 80 inches of rain last year and he sees he will have many challenges ahead. Brian's presentation focused on how bills are calculated, high water bills and future water projects in San Antonio Heights. Anyone wishing to review his slide presentation may log into The San Antonio Water Company Web Site. Brian noted the overall usage is very close to our allotted shares. He reminded everyone to check for sprinkler leaks by walking their yard looking for flooded areas and reviewing the water bill for any spike in usage. Customers may also check for leaks through their water meter. The round red dial is a low flow indicator that visibly rotates when you are using water. You can use this low flow indicator feature as an investigative tool. If all faucets, spigots and other water consumption devices are turned off both inside and outside your home, and the low flow indicator is rotating, you may have a water leak. If you can't locate the leak, please contact a plumber or SAWCo for assistance. American Leak Detection will pay up to \$500, or not more than half, of the repair. Brian recommends residents reducing length of showers and replacing old toilets with lower gpm (gallons per minute). SAWCo realizes the future for lowering costs is to install smart meters and the feasibility will be reviewed in 2019. The biggest problem to replace existing meters is the cost. The Cucamonga cross walls have been in place since 1930 and have accumulated tons of silt and dirt. In 2018 GRB Equipment was contracted to remove material from between the cross walls and they anticipate completion of this phase November 16. Seven repairs were made on the Reservoir, the 20th Street water line was replaced, and the first of two 120,000-gallon water tanks to replace the 60,000-gallon tank at Holly Drive will be scheduled to be done soon. Brain completed his remarks stating he has an open-door policy and to please contact him whenever there is an issue.

San Antonio Heights Resident Lisa Petschow gave an overview of the United States Postal Service Informed Mail Delivery. By signing up for this service, either online or at the post office, you will receive a photo of your daily mail and arriving packages. If something is missing, you will know immediately. You may also check your account online if you are away. This is a very useful tool to help our Sheriff track stolen mail and packages.

County Supervisor, District 2, Janice Rutherford reported Dianna Lee was in a serious accident two months ago. She is recovering but it will take time before she returns to her position. Janice introduced Division Chief Grant Mann and District Representative and Veterans Affairs Specialist Benjamin Lopez. She encouraged everyone to visit their table to view a parcel map of county roads in San Antonio Heights and obtain Parcel Consolidation Forms to avoid paying duplicate taxes on the new Fire Expansion. Two new employees, Fernando Torres and Athena Nava, have been added to the Department of Public Health, Animal Care and Control Division. They will be helping with the evaluation and marketing of adoptable animals, development of rescue group contacts and transfers of animals to rescue groups. They also will offer education on humane care of animals and help place companion animals in appropriate homes. Contact Animal Services if you are having an event and wish to have a speaker. It is possible that the County Supervisor, District 3, position will be vacant if James Ramos is elected to the State Assembly. If he wins the election the remaining County Supervisors will appoint his replacement. If no decision is reached, the Governor will appoint his successor. California State Senator Mike Morrell and Supervisor Rutherford will host a Christmas reception and dessert contest on Thursday, December 13, 5-8 p.m. at the Jessie Turner Center in Fontana. The event is free, but guests are encouraged to donate items for youth in foster care.

Sheriff-Coroner John McMahon gave well-earned kudos to the two County Sheriff's Deputies in San Antonio Heights, Jon Thorp and Rich Farrow; recognized the new Captain in Fontana, Joe Bustamonte; thanked the 22 members of San Antonio Heights Citizens on Patrol; and reported there are currently 44 West Valley Search and Rescue members and 50 more volunteers are in training. He reported the no parking signs along Mount Baldy, around the dam, and other mountain areas have helped keep the crime to a minimum as it gives the sheriff leverage to tow vehicles. He invited everyone to attend the "Coffee with a Deputy" event Thursday, November 8, 9:00 a.m. at the San Antonio Heights Sheriff's Substation.

California Highway Patrolman Captain Kevin Porter outlined the vast area the Rancho Cucamonga office covers along the 210, 15, and 71 freeways including all unincorporated areas and thanked San Antonio Heights for their active community involvement. A special task force has been focused on ticketing people speeding, unauthorized vehicles using the HOV lanes, and drivers using their cell phones along the 210 freeway. He reported there was a bicyclist fatality on 25th and Mountain and a suicide attempt of someone jumping out of the car while traveling on Baldy Road. He encouraged everyone to attend the CHP driving course for seniors: Age Well, Drive Smart, held on Friday, November 2, from 1:00 to 3:00 p.m. at Central Park, Rancho Cucamonga Hall, 11200 Baseline Road, Rancho Cucamonga. Captain Porter closed by introducing Public Information Officer Jesus Garcia who will be available after the meeting to answer questions and asked if anyone has any concerns to call the Highway Patrol (909) 980-3994.

San Bernardino County Fire Chief Mark Hartwig thanked the Heights residents for inviting him back for his eighth annual meeting. He attends about 30 district community events each year and commended the Heights for their annual Steakfest and Breakfast. He thanked Area Chief Jeff Birchfield and his team for all their efforts. When he became Fire Chief there were two people assigned to Station 12. During a fire, one person is needed on the pump, a second person is needed on the nozzle, and a third person feeds the hose, so the challenge was getting the third person permanently assigned to Station 12. Since the annexation the station is fully manned. 8 out of 10 calls are for medical emergencies so additional training was given to personnel and now each truck has a paramedic on call. Now that Station 12 has been combined with other Upland Stations the call count has gone from 500 to 800 calls per year. Because of the additional dollars from the FP-5 Annexation a new station is now possible, and the County can make capital improvements. Our current station does not have enough property space to expand so it is possible the station will be two-stories. Sadly, the old tree in front of station 12 died and needed to be cut down. Talented fire personnel turned the wood into kitchen tables at multiple stations and the remaining stump will be some type of woodcarving.

Upland Mayor Debbie Stone thanked the Heights residents for including the City of Upland in their meeting and the Upland City Council members and staff for their attendance. There are many positive projects in Upland in 2018. The Colonies continues to expand, the two largest being CNC Motors and the October 31 grand opening of In-n-Out. Sycamore Hills has multiple stores and will soon have a Wendy's and Corner Bakery. On November 1 the new Aldi's store opened at the Mountain Green Center just north of the 10 Freeway. Sweet Obsession Cheesecakes at the Historic Train Depot and the Euclid/Foothill Center, which is anchored by Burlington Coat Factory, are also open. The City is currently working on resurfacing the area around the post office (Arrow Highway and Third Street), and 7th, 13th,

14th, 19th, and 22nd Streets. New lights are being installed along the Pacific Electric Bike Trail which will be resurfaced later. The \$16.5 million project to replace the 7.5-million-gallon water tank on Benson and 17th Street has been approved. The City and Council are focused on renewing Upland Pride to the community.

BUSINESS MEETING

Minutes - Bob Cable asked for approval of the 2017 Annual Meeting Minutes. Ken Petschow moved the minutes be approved as distributed, Linda Keagle seconded, and the motion was carried. **Treasurer's Report** - Donna Hawthorne reported the SAHA Operating Account \$9,425.67, STAR Account \$1,248.89 and LEGAL Account \$1,741.54

Citizens on Patrol (COP) – Herb Rosenzweig reported that long-time resident and COP member, Bob Stinnett, passed and commended his years of volunteering. The Heights COP was incorporated on July 4, 1995, the same anniversary day our great Nation was founded. The COP is a volunteer unit of the Sheriff's Department consisting of 22 members, including three new members added in 2018. The COP provides visibility in our community, home vacation checks, volunteer at the Sheriff's Substation, assists with fire traffic control and would like more volunteers to be members. Herb would like everyone to attend the "Coffee with a Deputy" event Thursday, November 8, 9:00 a.m. at the San Antonio Heights Sheriff's Substation.

President's Report – Bob Cable announced the current court date for the lawsuit against the County and FP-5 is scheduled for December 18 and would appreciate residents' continued support by attending the hearing. He reiterated the community loves the CHP, Sheriffs and Fire Fighters and the suit is political and not against any of our emergency personnel. Our current finances for the San Antonio Heights Association are good but we would love to have more money and members. New members can sign up tonight or they may call or email to get additional information. Bob Cable sincerely stated again how proud he is of our community and appreciates the support of all the neighbors. With everyone's support we will preserve our way of life in the Heights.

Election of Officers – Tom Gomez introduced the proposed new Board: Bob Cable, Dean Gallagher, Betty Garrison, Tom Gomez, Mike Gott, Donna Hawthorne, Linda Keagle, Grace Kendall, John Navarro, Ken Petschow, Elyse Skeate, Cindy Wirth, and Francesca Zummo. Nita McElwain was nominated by Grace Kendall from the floor and the 2019 Board was approved.

Questions and Answers:

Captain Kevin Porter, California Highway Patrol, responded to speeding issues along 20th and surrounding areas where customers at CNC Motors are test driving cars (speeding). They are aware of the issue and working closely with the Sheriff's Department. Captain Porter believes the issues will be resolved quickly as his wife knows the owner's mother and will be speaking to her about the issue soon.

A question regarding the Euclid Avenue Right of Way that is currently 100 feet and should be 120 feet will be published (I need some help, please. I am not sure about this question or the answer. If anyone has more information, please contact the SAH message phone at (909) 638-1673 and we will amend the minutes.)

Multiple people inquired about the speed of the bicyclist killed at Mountain and 25th – as it is an on-going investigation information is not available, but it is believed he was within the guidelines of the speed limit. Captain Porter drove the area with his lieutenant to get a clear picture of the accident site. They found most bicyclists have good lights and helmets, but it is difficult for anyone in a vehicle to see oncoming bicyclists on a blind hill. Ron who lives on 25th has observed drivers going around 65 mph where the biker was hit and hopes there will be more citations issued in the future. He also noted 23rd Street appears to be the new alternate route during high traffic periods on the 210 Freeway. Captain Porter asked that Ron discuss his observations with Officer Garcia to get specifics on enforcement on these issues.

Supervisor Janice Rutherford answered why a stop sign has not been installed at Mountain and 25th. She explained there are multiple studies that must be performed and State laws the County must follow prior to any new installation of stop signs. She requested those wanting clearer information to speak to her staff and if they could not immediately respond to their questions, they would have an answer in a timely manner.

Mayor Debbie Stone was thanked for completing a request from the 2017 Annual Meeting to clearly mark center mediums on Benson between Holliday Rock and Mountain Avenue.

SAWCo General Manager Brian Lee responded to an inquiry regarding reuse of greywater. They must follow County regulations and SAWCo is working with them and the issue is being considered.

A Heights resident wanted updated information on the replacement of existing water meters to smart meters. Brian understands the City of Upland is the major shareholder but because of the way the water is distributed to the City it will be a difficult process to determine how best to proceed. SAWCo is reviewing costs for replacing meters in the Heights first and he would like to talk to all shareholders on this issue before any decisions are made.

A Heights resident is concerned about a rumor they heard that Governor Jerry Brown wants to fine household (interior) water use over 50 gallons per day. Brian says this is not a burden for SAWCo yet as people are under that amount and does not feel it will impact the value of SAWCo water shares as the law will most likely not apply to Heights residents. It is not 50 gallons per day per household, but per person. Brian was in the San Francisco area when the 50-gallon rule went into effect and it was impossible to achieve.

Several residents asked about the different types of smart meters, radiation concerns, how much control the water company will have when new meters are installed and if residents will have the option to not install the new meters. SAWCo is currently replacing meters on an as needed basis—example is the 15-year old meter replaced in August with a smart meter. The new meters will send text messages so it cannot be controlled by water personnel and does not emit radiation. SAWCo is currently reviewing opt-out options.

Terri Layton, SAWCo Assistant General Manager, explained the meters have a download mode so past usage can be reviewed – it is not instant information. Regarding new construction, a shareholder company is required to have shares to build and a landscape plan. Even though Upland owns 68% of the water shares, they rarely reach their maximum and they can't have more water than their entitlement. SAWCo can only regulate the water shares and make suggestions for new building. There are good conservation people in Upland reviewing plans.

Sheriff John McMahon discussed thefts in the Heights. A concerned citizen wrote a letter to Bob Cable and the SAHA Board of Directors regarding car thefts and decoration thefts on Mountain and Mesa Court. The residents would like either the Heights Association or the residents to install cameras on both sides of the street and inquired about the legality. Bob Cable stated the Heights Association cannot do that, but residents can. Sheriff McMahon stated cameras may be installed on private property only, not public. Another resident requested a stop sign be installed on 25th Street and Vista. Deputy Farrow responded that 8 out of 10 tickets given in the area are to residents and it has been patrolled heavily since there have been 3 major accidents in that location.
